## QUALIFYING REQUIREMENT

### 1. **Modification work for extension of CW Pump House Crane support Structure at Expansion Power Plant, NSPCL-Bhilai.**

1. The average annual turnover of the Bidder in the preceding three financial years as on the date of Techno-commercial bid opening **shall not be less than Rs. 38.49 lakhs.**
2. The bidder should have executed either of the following completed similar works within preceding 07 (seven) years reckoned as on the date of bid opening:-
  - a) Three similar completed works costing not less than the amount equal to **Rs. 12.83 lakhs each** (inclusive of taxes).  
OR
  - b) Two similar completed works costing not less than the amount equal to **Rs. 16.04 lakhs each** (inclusive of taxes).  
OR
  - c) One similar completed works costing not less than the amount equal to **Rs. 25.66 lakhs** (inclusive of taxes).

#### **Note:**

- ◆ **Similar works means:-** The completed works comprising Building construction job which including RCC works of foundation & columns and steel structure works.

**Completed means:-** The executed/ completed portion of BOQ, even if the work has not been completed in totality (subject to furnishing of documentary proof of executed value of the work).

- ◆ While computing the annual turnover other income shall not be considered.
- ◆ In case where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall be considered acceptable.

## **NIT Conditions**

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a **crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai**) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
