QUALIFYING REQUIREMENT

1. Supply, Erection and commissioning of Fire Detection and alarm system for Main Plant and CHP in PP-II.

1. The average annual turnover of the Bidder in the preceding three financial years as on the date of Techno-commercial bid opening **shall not be less than Rs. 112.22 Lakhs.**
2. The bidder should have supplied, erected & commissioned or supplied, got erected & got Commissioned fire detection system in Power Plant/ Refinery/ Metal and Heavy Industry during preceding 07 (seven) years reckoned as on the date of techno commercial bid opening, should be either of the following:
 - Three similar completed works costing not less than the amount equal to **Rs. 29.92 Lakhs each** (inclusive of taxes)
OR
 - Two similar completed works costing not less than the amount equal to **Rs. 37.40 Lakhs each** (inclusive of taxes).
OR
 - One similar completed works costing not less than the amount equal to **Rs. 59.85 Lakhs** (inclusive of taxes).

Note:

- ◆ While computing the annual turnover other income shall not be considered.
- ◆ In case where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO/Proprietor/Partners as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

NIT Conditions

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a **crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai**) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
