QUALIFYING REQUIREMENT

1. Brick Paving work in misc. areas of PP-III (Year 2017-18).

1. The average annual turnover of the Bidder in the preceding three financial years as on the date of Techno-commercial bid opening **shall not be less than Rs. 49.65 Lakhs.**
2. The bidder should have experience of successfully completing the similar works within preceding 07 (seven) years reckoned as on the date of NIT publication:-
 - Three similar completed works costing not less than the amount equal to **Rs. 19.85 Lakhs each** (inclusive of Service Tax/GST)
OR
 - Two similar completed works costing not less than the amount equal to **Rs. 24.82 Lakhs each** (inclusive of Service Tax/GST).
OR
 - One similar completed works costing not less than the amount equal to **Rs. 39.71 Lakhs** (inclusive of Service Tax/GST).

Note:

- ◆ **Similar works means:** The completed works comprising any civil maintenance/construction work.

Completed Works means:- The executed/ completed portion of BOQ, even if the work has not been completed in totality (subject to furnishing of documentary proof of executed value of the work).

- ◆ While computing the annual turnover other income shall not be considered.
- ◆ In case where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall be considered acceptable.

NIT Conditions

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a **crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilaj**) for issue of bid documents without prima-facie examination of their qualification status.
