#### **Instruction for e-bidding:**

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
- a) Login the SRM Portal and click on RFx and Auction button.
- b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
- c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
- d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.
- e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:
- a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till 3.8.22 to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in
- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## **QUALIFYING REQUIREMENT**

Name of Work: "BIENNIAL MAINTENANCE OF TURBINE, DMP AND OFFSITE AREA OF CPP II, Durgapur".

## 1) Financial Criteria:

The average annual turnover of the bidder in the preceding three(03) financial years as on the date of bid opening shall not be less than 122.09 lakhs.(Rupees One hundred twenty two lakhs nine thousands only)

## 2)Technical Criteria:

- 2.1)The bidder must have successfully Executed the works of maintenance of Turbine and/or "Turbine auxiliaries and turbine offsite area" in a thermal power plant consisting of Unit capacity of 60MW or more. Turbine auxiliaries shall include mainly pumps, heat exchanger, coolers, Deaerators, valves, piping, Air conditioning system, air compressor. Turbine offsite shall include mainly cooling tower, CW pumps, fire fighting system and all DM plant equipment maintenance or any combination of any of above equipments or all the equipments.
- 2.2) The bidder should have executed similar works mentioned under 2.1 during preceding 7 (Seven) years reckoned as on date of Techno-commercial Bid opening, having executed value as under
  - a. Single Work order of value not less than Rs 97.67 lakhs.(Including taxes & Duties)

b. Two Work Order of value not less than Rs 61.04 lakhs each.(Including taxes & Duties)

c. Three Work Order of value not less than Rs 48.84 lakhs each.(Including taxes & Duties)

#### Note:

- 1)The word "executed" means that the bidder should have achieved the Progress specified in the Techno-Commercial bid even if total Contact/order is not completed/closed. The same shall be supported by documentary evidence issued by the Owner/Employer such as completion certificate/joint Protocol/Running Final Bills.
- 2) The word "similar works" mentioned in para 2.1
- 3)For financial selection criteria, QR para 1, bidder must submit copy of audited balance sheet and profit & loss account for the specified period. In case where audited results for the last financial year as on last date of Techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three (03) consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
- 4)All values mentioned in 2.2 shall be inclusive of all taxes and duties.
- 5)Other income shall not be considered for calculation of annual turnover.
- 6) Neccessary documentary evidence in support requirements of QR are to be furnished by the bidder.

#### **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee.
