#### **Instruction for e-bidding:**

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:
  - a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in forms, till 05/09/23 to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at <a href="mailto:nbarelee@nspcl.co.in">nbanerjee@nspcl.co.in</a> or <a href="mailto:rnshukla@nspcl.co.in">rnshukla@nspcl.co.in</a> or <a href="mailto:rnshukla@nspcl.co.in">rnshukla@nspcl.co.in</a>
  - b) C&M department will initiate the process for vendor ID creation in SAP & send the bidder's SRM Credentials (User ID along with initial Password) to them.
  - c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

# **QUALIFYING REQUIREMENT**

Name of Works: "Civil Maintenance work in NSPCL quarter at DSP Township, Durgapur".

#### 1.0 FINANCIAL CRITERIA:

**1.1 Turnover**: The Average Annual Turnover of the Bidder should not be less than **Rs. 52.34 Lacs**, in the preceding 03 (Three) Financial Years, as on the date of Technical bid opening.

#### 2.0 TECHNICAL CRITERIA:

- **2.1** The bidder should have executed the Repair/maintenance of Township buildings/drains/water supply systems or other miscellaneous civil jobs or similar works within preceding 7 years reckoned as on the date of bid opening –
- (a) Single Work Order of value of Rs. 41.87 Lacs (Including taxes & duties).

OR

(b) Two Work Orders of value of Rs. 26.17 Lacs each (Including taxes & duties).

OR

(c) Three Work Orders of value of Rs. 20.93 Lacs each (Including taxes & duties).

#### NOTE:

- 1. The Word "Executed" means that the bidder should have achieved the progress specified in the QR, even if total contract/ work order is not completed/ closed. The same shall be supported by documentary evidence issued by the owner/ employer such as Completion Certificate/ Joint protocol / Running / Final Bills etc.
- 2. **'Similar Work'** means the agency must have the experience of executing any Civil works involving Concrete Work (RCC/PCC), Brick Work, Plaster work, Painting/ Tiles etc.
- 3. For Financial selection Criteria, QR para 1.0, Bidder must submit copy of Audited Balance Sheet and Profit & Loss Account for the specified period. In case, where audited results for the Last Financial year as on the Last date of technical bid opening, are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from the practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years proceeding the last financial year, shall be considered for evaluating the financial parameters.
- 4. Other Income shall not be considered for calculation of Annual Turnover.

### **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. Being works contract, MSE Benefit is not applicable.
- 6. Note: Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
