#### Instruction for e-bidding:

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- **3.** New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:
  - a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in forms, till **07.07.23** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at <a href="mailto:nbanerjee@nspcl.co.in">nbanerjee@nspcl.co.in</a> or <a href="mailto:rnshukla@nspcl.co.in">rnshukla@nspcl.co.in</a>, <a href="mailto:rnshukla@nspcl.co.in">rnshukla@nspcl.co.in</a>)

- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidder's SRM Credentials (User ID along with initial Password) to them.
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## **QUALIFYING REQUIREMENT**

Name of Work: "Replacement of GI and Asbestos Sheet and Fixing of Colour Coated Sheet in Different Areas of 2x60 MW Power Plant at NSPCL Durgapur".

#### 1.0 Technical Criteria:

The bidder should have executed "the civil maintenance / civil repair/ civil construction work with Bill of Quantity (BOQ) item for roof sheeting / cladding" during last seven (07) years as on the date of Techno-commercial Bid Opening with either of the following:

- a) Single order having a value not less than **Rs. 72.11 Lakh (including taxes and duties)**OR
- b) Two orders having a value not less than **Rs. 45.07 Lakh each (including taxes and duties)**

OR

c) Three orders having value not less than **Rs 36.06 Lakh each (including taxes and duties)** 

#### 2.0 Financial Criteria:

2.1 Average Annual Turnover of the Bidder, in preceding three (03) financial years as on the date of Techno-commercial shall bid opening, shall not be less than **Rs. 60.09 Lakh** (Sixty lakh and nine thousand only).

#### **NOTES:-**

- i) The word "executed" means that the bidder should have achieved the above specified eligibility criteria during last seven (07) years as on date of Techno-commercial bid opening even if the contract has been started earlier and /or is not completed/ closed. The same shall be supported by documentary evidence issued by the owner/ employer such as completion certificate or Joint Protocol or Running/ Final bills.
- ii) Contract for pure earth work/pure steel fabrication/pure road work/pure water supply/drainage piping work/pure aluminium work shall not be considered. The contract for the Civil maintenance/ civil repair/ civil construction work with bill of Quantity (BOQ) item for roof sheeting / cladding shall be considered.
- iii) For Financial selection Criteria, QR para 2.0, Bidder must submit copy of Audited Balance Sheet and Profit & Loss Account for the specified period. In case, where audited results for the Last Financial year as on the date of Techno-commercial bid opening, are not available, the Financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from the practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year, shall be considered for evaluating the financial parameters.
- iv) Other Income shall not be considered for calculation of Annual Turnover.
- v) All values mentioned in 1.0 shall be inclusive of all taxes & duties.

### **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. The subject work being works contracts, benefits under public procurement policy for MSEs shall not be extended against this tender
