## **Instruction for e-bidding:**

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
- a) Login the SRM Portal and click on RFX and Auction button.
- b) RfX will be available to view for all the bidders which are already having valid SRM User ID's.
- c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into RfX header segment.
- d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.
- e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- **3.** New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:
- a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till **20.08.2022** to C&M

- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

#### **OUALIFYING REOUIREMENTS**

The Bidders who wish to participate in the Bidding shall satisfactorily establish that they fulfill the following Qualifying Requirement:

#### 1.0 Technical Criteria

- 1.1 The Bidder should be manufacturer and should have credential of fabricating / Manufacturing and supplying a minimum of 20 similar fire tenders with Corrosion Free Extruded Aluminum Profile Sections, Sub frame system for Tank Mountings & Metacone systems in last 02 years as on date of Technical Bid Opening. Manufacturer shall have experience of minimum 10 years in the field of Fire Tender manufacturing. The manufacturer shall provide PO copy in this regard along with the offer.
- 1.2 The Bidder should have executed the supply of similar order successfully during last 07 years as on date of Technical Bid opening having purchase order value in any of the following manner.
  - a. Single order value not less than Rs. 65,84,400 /-

or

b. Two orders (02) each of value not less than Rs. 41,15,250 /-

or

c. Three orders (03) each of value not less than Rs.32,92,200/-

#### 2.0 Financial Criteria

2.1 The average annual turnover of the bidder should not be less than Rs.82,30,500 /(Rupees Eighty two lakh thirty thousand Five hundred only- inclusive of taxes)
during the preceding three (03) Financial Years as on the date of Technical Bid
opening.

#### Notes:

- Similar order means works of Fabrication/Manufacturing and Supply of Fire tenders with corrosion Free Extruded Profile sections, Sub frame for Tank Mountings & Metacone Systems.
- 2. The bidder has to submit Documentary Evidence in support of Clause 1.2 of QR.
- 3. Values as per clause 1.2 shall be considered inclusive of taxes & duties.
- 4. Other income shall not be considered for arriving at annual turnover.
- 5. In case where audited results for the last financial year as on the first scheduled date of Technical bid opening are not available, the financial results certified by a practicing Charted Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Charted Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO/Proprietor/Partners as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on date of Technical bid opening and Certificate from the practicing Charted Accountant certifying the financial parameters is not available.

## **NIT Conditions**

- 1. - 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Issuance of Bidding Documents to any bidder shall not construe that bidder is considered qualified.
- 4. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.

- 5. Small-scale industries registered with UDYAM shall be exempted for payment of EMD & Tender Fee.
  - (Subject to submission of copy of registration giving details, such as validity, monetary limit, etc.)
- 6. NSPCL shall allow purchase preference, as indicated in the bidding documents, to bids from local suppliers as defined in the bidding documents. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- 7. Notwithstanding anything stated above, the Employer reserves the right to undertake a physical assessment of the capacity and capabilities including financial capacity and capability of the Bidder / his Collaborator(s) /Associate(s) / Subsidiary(ies) / Group Company(ies) to perform the Contract, should the circumstances warrant such assessment in the overall interest of the Employer.

The physical assessment shall include but not be limited to the assessment of the office/facilities/banker's/reference works by the Employer. A negative determination of such assessment of capacity and capabilities may result in the rejection of the Bid.

The above right to undertake the physical assessment shall be applicable for the qualifying requirements stipulated above.

8. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
