- The bidder must have Digital Signature Certificate (Class-III).
- The bidders who already have valid SRM User ID:
  - Login the SRM Portal and click on RFX and Auction button.
  - RFX will be available to view for all the bidders which are already having valid SRM User ID's.
  - Interested bidders have to register first against the Bid invitation by clicking on “Register” button placed into RFX header segment.
  - Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to “Create Response” and submit the bids against the Bid invitation into the system.

<b>1.1</b>	The bidder should have Experience of completing similar works successfully during last 07 years as on the first scheduled date of technical bid opening having minimum PO values in any of the following manner.
	i) 01 (One) similar order of value not less than <b>Rs.63.47 Lakhs.</b> (inclusive of taxes) OR ii) 02 (two) similar orders of value not less than <b>Rs.39.67 Lakhs each.</b> (inclusive of taxes) OR iii) 03 (Three) similar orders of value not less than <b>Rs.31.73 Lakhs each.</b> (inclusive of taxes)
<b>2.0</b>	<b>Financial requirement</b>
<b>2.1</b>	The average annual turnover of the Bidder, should not be less than <b>Rs. 79.33 Lakhs</b> ( Rupees Seventy-Nine lakhs thirty three thousand only) during the preceding three (03) financial years as on the first schedule date of Technical bid opening.
<b><u>टीप Notes</u></b>	<p>I) The phrase "Similar works" means: The bidder should have successfully executed any "Civil maintenance/ Civil Repair/ Civil Construction work" as on the first scheduled date of technical bid opening.</p> <p>II) Completed works means: The executed / completed portion of BOQ, even if the work has not been completed in totality (Subject to furnishing Proof of executed value of the work in the form of copies of RA Bills, Relevant PO Copy and clients completion certificate/RA bill/Final Deviation Statement).</p> <p>III) Values as per clause 2.1 shall be considered inclusive of taxes and duties.</p> <p>IV) Other income shall not be considered for arriving at annual turnover.</p> <p>V) In case where audited results for the last financial year as on the first scheduled date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable.
