#### **QUALIFYING REQUIREMENTS:**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder.

#### **1.0 Technical Requirement:**

- 1.1 The bidder should be a manufacturer of Transformer oil.
- 1.2 The bidder should have completed similar works successfully during last 07 years as on the date of technical bid opening having minimum Purchase Order values in any of the following manner:
- i. Single order having executed value of not less than Rs **71.096 lakhs**.
- ii. Two orders having executed value of not less than **Rs 44.43 lakhs** each.

iii. Three order having executed value of not less than **Rs. 35.54 lakhs** each.

#### 2.0 Financial Requirement:

The average annual turnover of the Bidder should not be less than **Rs 88.87 lakhs** (Rupees Eighty-Eight Lakh Eighty-Seven Thousand only inclusive of taxes) during the preceding three (03) financial years as on the date of technical bid opening.

#### NOTES:

- I. The phrase Similar Works means: Supply of Transformer oil
- II. Completed work means: The executed /completed portion of BOQ, even if the work has not been competed in totality (subject to furnishing proof of executed value of the work in the form copies of RA Bills, Relevant PO copy and client's completion certificate/RA bill/Final Deviation Statement).
- III. Values as per clause 1.2 shall be considered inclusive of taxes & duties.
- IV. Other income shall not be considered for arriving at annual turnover.

In case where audited results for the last financial year as on the date of technical bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, bidder is not able to submit the certificate from a practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
