Instruction for e-bidding:

1. The bidder must have Digital Signature Certificate (Class-III).
2. The bidders who already have valid SRM User ID:
 - a) Login the SRM Portal and click on RFx and Auction button.
 - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
 - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
 - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:
 - a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in forms, till **11.02.2024** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at nbanerjee@nspcl.co.in or rshukla@nspcl.co.in or prabhulinga@nspcl.co.in or ushakumai@nspcl.co.in or rashmikumari@nspcl.co.in.

b) C&M department will initiate the process for vendor ID creation in SAP & send the bidder's SRM Credentials (User ID along with initial Password) to them.

c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

1.1	FINANCIAL CRITERIA
1.1.1	The bidder should have executed the following similar works within the preceding 07 years of scheduled technical bid opening date which fulfils either of the following criteria as follow
1.1.2	(i) 01 (One) similar completed works costing not less than the amount equal to Rs.50.36 Lakh OR (ii) 02 (Two) similar completed works costing not less than the amount equal to Rs.31.48 Lakh each. OR (iii) 03 (Three) similar completed works costing not less than the amount equal to Rs.25.18 Lakh each.
1.1.3	The average annual turnover of the Bidder in the preceding three (03) financial years as on the date of Techno-Commercial bid opening should not be less than Rs. 62.96 lakh.
Notes:	<p>i) Similar work means: The bidder should have executed the work of ASH Dyke Construction or ASH Dyke Raising OR ASH Dyke Maintenance or Construction of earthen embankment of Civil Construction Works or Civil Maintenance Works.</p> <p>II) Completed works means: The executed / completed portion of BOQ even if the work has not been completed in totality (Subject to furnishing Proof of executed value of the work in the form of copies of RA Bills, Relevant PO Copy and clients completion certificate/RA bill/Final Deviation Statement).</p> <p>III) Reference work executed by bidder as a sub-contractor may also be considered provided the certificate issued by the main contractor is duly certified by the Project Authority specifying the work executed by the sub -contractor in support of the qualifying requirements..</p> <p>IV) The bidder shall submit the Audited Balance Sheet and Profit & Loss Account for the specified period. In case where Audited results for the preceding FY are not available, certificate of financial statements from a practicing Chartered Accountant shall also be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Account certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.</p> <p>V. Other income shall not be considered for arriving annual turnover.</p> <p>(VI) All the values mentioned in the Clause 1.1.2 & 1.1.3 are inclusive of taxes and duties.</p>
