Instruction for e-bidding:

1. The bidder must have Digital Signature Certificate (Class-III).
2. The bidders who already have valid SRM User ID:
 - a) Login the SRM Portal and click on RFX and Auction button.
 - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
 - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
 - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

1.1	FINANICAL CRITERIA
1.1.1	The bidder should have executed the following similar works within the preceding 07 years of scheduled technical bid opening date which fulfils either of the following criteria as follow
1.1.2	(i) 01 (One) similar completed works costing not less than the amount equal to Rs.50.36 Lakh OR (ii) 02 (Two) similar completed works costing not less than the amount equal to Rs.31.48 Lakh each. OR (iii) 03 (Three) similar completed works costing not less than the amount equal to Rs.25.18 Lakh each.
1.1.3	The average annual turnover of the Bidder in the preceding three (03) financial years as on the date of Techno-Commercial bid opening should not be less than Rs. 62.96 lakh.
Notes:	<p>i) Similar work means: The bidder should have executed the work of ASH Dyke Construction or ASH Dyke Raising OR ASH Dyke Maintenance or Construction of earthen embankment of Civil Construction Works or Civil Maintenance Works.</p> <p>II) Completed works means: The executed / completed portion of BOQ even if the work has not been completed in totality (Subject to furnishing Proof of executed value of the work in the form of copies of RA Bills, Relevant PO Copy and clients completion certificate/RA bill/Final Deviation Statement).</p> <p>III) Reference work executed by bidder as a sub-contractor may also be considered provided the certificate issued by the main contractor is duly certified by the Project Authority specifying the work executed by the sub -contractor in support of the qualifying requirements..</p> <p>IV) The bidder shall submit the Audited Balance Sheet and Profit & Loss Account for the specified period.
