- **2.** The bidders who already have valid SRM User ID:

  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:
  - a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in forms,

# **QUALIFYING REQUIREMENT**

Name of Work: "SUPPLY, SUPERVISION OF INSTALLATION & COMISSIONING OF TG # 1,2 PLC SYSTEM".

1.1	Technical Criteria				
1.1.1	The bidder should be a Manufacturer/ Authorised System Integrator of PLC / DCS of reputed make namely Emerson/Schneider/BHEL/Yokogawa/Siemens/ABB/Honeywell/Rockwell & have supplied PLC / DCS System in any Power plants consisting of individual Turbo Generator capacity of 30 MW or more than 30 MW directly or through Turbine manufacturer/ EPC Contractor within last 07 years. The commissioned PLC / DCS system should have been in successful operation for at least one year prior to the date of techno-commercial bid opening.  AND  1.1.2. The bidder should have executed orders of supply with Installation & commissioning of 'PLC/ DCS System during last seven (07) years prior to the date of techno commercial bid opening in any of the following manner-:				
	a) One (1) order having Executed value not less than Rs. 113.88 Lakhs OR				
	b) Two (2) orders having Executed value not less that Rs. 71.17 Lakhs each OR				
	c) Three (3) orders having Executed Value not less than Rs56.94 Lakhs each.				
Notes For Technical Criteria	(i) The word <b>"Executed"</b> mentioned above means that the bidder should have completed the job. (Work Completion certificate may be accepted as supporting document even if contract is not closed)				
	(ii) In case of orders under execution, the value of work executed prior to the date of techno-commercial bid opening duly certified by bidder's client shall be considered acceptable.				
	(iii) Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.				
	(iv) The Figure indicated in 1.1 are inclusive of taxes & Duties.				
1.2	Financial Criteria				
	<b>1.2.1</b> The bidder who wishes to participate in the bidding shall satisfactorily establish that they fulfil the following qualifying requirement.				
	<b>1.</b> The Average Annual Turnover of the bidder, in the preceding three (3) financial years as on				

the date of bid opening shall not be less than Rs 142.35 Lakhs (Rupees One Crore Forty-Two Lakhs Thirty-Five Thousand Only).

**1.2.2.**In case where audited results for the last financial year as on the date of technical bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

### **Notes**

- 1. **Other income** shall not be considered for computing annual turnover.
- 2. The figures indicated in 1.2 are inclusive of Taxes and Duties.
- 3. Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).

## **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status.
