  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.

# **QUALIFYING REQUIREMENT**

Name of Work: "REPAIR & STRENGHTENING OF ROAD FROM ASH DYKE PP3/ MGR BRIDGE NO. 5 TO MAIN ROAD NEAR BRIDGE NO. 3, NSPCL-BHILAI".

#### 1.0 Technical Criteria:

- 1.1 The bidder should have executed road (s) including Pre-mix bituminous carpet and/or RCC roads and/or minor bridge and culvert at any industrial organization/ utility within preceding seven (07) years as on the date of Techno-commercial Bid Opening in any of the following manner:
  - a) One (1) order having contract value not less than `272.90 lakhs

OR

b) Two (2) orders having contract value not less than `170.56 lakhs each.

OR

c) Three (3) orders having value not less than `136.45 lakhs each.

#### NOTES for clause 1.1 above:

- 1. Documentary evidence like executed PO copies, proof of execution of order, copies of MB (Bills/ receipts) etc. shall be submitted by bidder.
- 2. In case of composite contracts, a bidder has to give the breakup of composite PO value.
- 3. Bidder must submit NSIC/SSI/MSE registration certificate, if applicable.
- 4. The word "executed" means that the bidder should have achieved the criterion specified in the qualifying requirements with any of the following conditions:
  - i) **Case-I:** The work is started earlier (prior to the period stipulated in clause 1.1) but completed within the stipulated period as mentioned in clause 1.1. In such cases, entire executed quantity of the relevant work vide the work order shall be considered for evaluation.
  - ii) **Case-II:** The work is started and completed within the stipulated period as mentioned in clause 1.1. In such cases, entire executed quantity of the relevant work vide the work order shall be considered for evaluation.
  - iii) Case-III: The work is started within the stipulated period as mentioned in clause 1.1 but not completed as on the last date of stipulated period. In such cases, "in progress" executed quantity of the relevant work vide that work order as on the last date of stipulated period, shall be considered for evaluation.
- 5. In case of orders under execution, the value of work executed till the date of Techno- commercial bid opening duly certified by owner shall be considered acceptable.
- 6. Reference work executed by bidder as sub-contractor may also be considered provided the certificate issued by the main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.
- 7. The figures indicated are inclusive of Taxes & Duties.

### 2.0 Financial Criteria:

- 2.1 The average annual turnover of the Bidder, should not be less than `341.13 lakhs (Indian Rupees Three crores Forty-one lakh and Thirteen thousand only) during the preceding three (03) completed financial years as on the date of Techno-Commercial bid opening.
- 2.2 In cases where audited results for the last financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Technocommercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### **NOTES FOR FINANCIAL CLAUSE 2.0 ABOVE:**

Other income shall not be considered for arriving at annual turnover.								

# **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. - 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. The subject work being works contracts, benefits under public procurement policy for MSEs shall not be extended against this tender.

Note: Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
