Instruction for e-bidding:

- The bidder must have Digital Signature Certificate (Class-III).
- The bidders who already have valid SRM User ID:
 - Login the SRM Portal and click on RFx and Auction button.
 - Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
 - Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
 - Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:
 - In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in forms, till **28.08.23** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at nbanerjee@nspcl.co.in or rnshukla@nspcl.co.in or prabhulinga@nspcl.co.in or ushakumai@nspcl.co.in or rashmikumari@nspcl.co.in.
 - C&M department will initiate the process for vendor ID creation in SAP & send the bidder's SRM Credentials (User ID along with initial Password) to them.
 - After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

QUALIFYING REQUIREMENT

1	Technical Criteria:
1.1	<p>The Bidder should have successfully executed orders of Similar Works during last seven (07) years prior to the date of techno commercial bid opening in any of the following manner:</p> <p>a) One (1) order having executed value not less than Rs. 39.38 Lakh. OR b) Two (2) orders having executed value not less than Rs. 24.61 Lakh each. OR c) Three (3) orders having executed value not less than Rs. 19.69 Lakh each.</p>
	<p>Notes for Technical Criteria:</p> <ol style="list-style-type: none"> 1. The phrase “Similar Works” means ASSISTANCE IN PLANT/OFFSITE/STORES/OFFICES AREA. 2. The word “Executed” mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed. 3. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder’s client shall be considered acceptable. 4. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements. 5. The Figure indicated in 1 are inclusive of taxes & Duties.
2	Financial Criteria:
2.1	<p>The bidder who wishes to participate in the bidding shall satisfactorily establish that they fulfil the following qualifying requirement.</p> <ol style="list-style-type: none"> 1. The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of bid opening shall not be less than Rs. 49.23 Lakhs. (Rupees Forty Nine Lakh & Twenty Three Thousands Only).
2.2	<p>In case where audited results for the last financial year as on the date of technical bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.</p> <p>Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Technical bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available</p>
Note	<ol style="list-style-type: none"> i) Other income shall not be considered for computing annual turnover. ii) The figure indicated in 2 are inclusive of taxes & duties

NIT Conditions

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a **crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai**) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
5. Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee.

Note: Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
