  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

1.1	The Bidder should have successfully executed orders of <b>Similar Works</b> during seven (07) years prior to the date of techno commercial bid opening in any of following manner:					
	a) One (1) order having executed value not less than <b>Rs. 39.38 Lakh</b> .  OR b) Two (2) orders having executed value not less than <b>Rs. 24.61 Lakh</b> each.  OR					
	c) Three (3) orders having executed value not less than <b>Rs. 19.69 Lakh</b> each.					
	Notes for Technical Criteria:  1. The phrase "Similar Works" means ASSISTANCE IN PLANT/OFFSITE/STORES/OFFICES AREA.  2. The word "Executed" mentioned above means that the bidder should have					
	achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.					
	3. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.					
	4. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.

2.2	In case where audited results for the last financial year as on the date of technical bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered					
	Accountant certifying its financial parameters, the audited results for the three					
	consecutive financial years preceding the last financial year shall be					
	considered for evaluating the financial parameters.					
	Further, a Certificate would be required from the CEO/CFO as per the format					
	enclosed in the bidding documents stating that the Financial results of the					
	Company are under audit as on the date of Technical bid opening and the					
	Certificate from the practicing Chartered Accountant certifying the financial					
	parameters is not available
