Instruction for e-bidding:

1. The bidder must have Digital Signature Certificate (Class-III).

2. The bidders who already have valid SRM User ID:

a) Login the SRM Portal and click on RFx and Auction button.

b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.

c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.

d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.

e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.

3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:

a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till 10/12/2021 to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in

b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)

c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

QUALIFYING REQUIREMENT

Name of Works: "BMC of Pressure Parts at Rourkela PP2".

TECHNICAL CRITERIA:

 The bidder shall possess valid Special Class/ First Class boiler repair license issued by Directorate of Factories & Boilers, Govt of Odisha and submit along with bid. OR

The bidder should submit undertaking along with the bid that they will submit special Class/ First Class boiler repair license issued by Directorate of Factories & Boilers, Govt of Odisha within 15 days of issue of LOI.

- 2. The bidder should have executed similar works during the last 07 (seven) years of scheduled technical bid opening date which fulfils either of the following criteria
- i) Three similar completed works costing not less than the amount equal to Rs.**27.70 lakh** each (Rupees Twenty Seven Lakh and Seventy Thousand Only). OR
- ii) Two similar completed works costing not less than the amount equal to Rs.34.62 lakh each (Rupees Thirty Four Lakh and Sixty Two Thousand Only).
 OR
- iii) One similar completed works costing not less than the amount equal to Rs.**55.40 lakh** each (Rupees Fifty Five Lakh and Forty Thousand Only).

FINANCIAL CRITERIA:

3. The average annual turnover of the bidder in preceding three (03) financial years as on the date of techno commercial bid opening shall not be less than Rs. 69.25 lakhs.

<u>NB:</u>.

- (i) The word "Executed" means either the total contract/order is completed/closed or execution of the contract/ order is in progress. The same shall be supported by the documentary evidence issued by the owner.
- (ii) **Similar work Means**: Maintenance/ Overhauling of boiler pressure parts in a unit of 20MW or above in a thermal power plant.
- (iii) For QR number 2&3, bidder must submit documentary evidence in support of meeting QR like copy of works completion certificate from the client/ last running bill/ measurement book of reflecting last bill paid/ protocol jointly signed by owner and contractor/ works bills along with the LOA/PO copy.
- (iv) For QR number 3, The bidder shall submit the audited balance sheets & profit & loss account for the specified period. In case, where audited results for the last financial years as on the date of technical bid opening are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable. In case, Bidder is not able to submit the Certificate from the practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year, shall be considered for evaluating the financial parameters
- (v) Other Income shall not be considered for arriving Annual Turnover.

NIT Conditions

- Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC <u>SAIL POWER COMPANY LIMITED payable at Bhilai</u>) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. Bidder has to submit the Bid Security Declaration Form in lieu of EMD. NOTE: Bidder may note that in case they do not submit the aforesaid declaration or no Confirmation is indicated by them or statement/any declaration like 'later', 'to be Furnished later', 'NA' etc. are indicated against the declaration, then the bid shall be Rejected by EMPLOYER as being non-responsive and shall not be opened.
- 5. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 6. S Small-scale industries registered with NSIC/MSME/Udyam shall be exempted for payment of Tender Fee. *(Subject to submission of copy of registration giving details, such as validity, monetary limit, etc.).*
