**Instruction for e-bidding:**

1. The bidder must have Digital Signature Certificate (Class-III).

2. The bidders who already have valid SRM User ID:

a) Login the SRM Portal and click on RFx and Auction button.

b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.

c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.

d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.

e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.

3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:

a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till **28/08/2022** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: [prabhulinga@nspcl.co.in](mailto:prabhulinga@nspcl.co.in)

b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)

c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## QUALIFYING REQUIREMENT

**Name of Works: "Internal & External painting of NSPCL Quarters & CISF qtrs. in DSP Township."**

### **1.0 FINANCIAL CRITERIA:**

**1.1 Turnover :** The Average Annual Turnover of the Bidder, in the preceding 03 (Three) Financial Years, as on Date of Tech. Bid opening, shall not be less than **Rs. 67.26** Lakhs (Rupees Sixty seven lakh twenty-six thousand only).

### **2.0 TECHNICAL CRITERIA :**

**2.1** The bidder should have executed either following similar works within preceding 7 years reckoned as on the date of technical bid opening –

(a) Single Work Order of value of Rs. 53.80 Lakhs (Inclusive of taxes & duties).

OR

(b) Two Work Orders of value of Rs. 33.63 Lakhs each (Inclusive of taxes & duties).

OR

(C) Three Work Orders of value of Rs. 26.90 Lakhs each (Inclusive of taxes & duties).

### **NOTE:**

1. **Similar Work means** the works comprising Building Construction/repair work and /or building painting work.
2. The Word "**Executed**" means that the bidder should have achieved the progress specified in the QR para 2.1 even if total contract/ work order is not completed/ closed. The same shall be supported by documentary evidence issued by the owner/ employer such as Completion Certificate/ Joint protocol / Running / Final Bills etc.
3. For Financial selection Criteria, QR para 1.0, Bidder must submit copy of Audited Balance Sheet and Profit & Loss Account for the applied period. In case, where audited results for the Last Financial year as on the date of technical bid opening, are not available, the Financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from the practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year, shall be considered for evaluating the financial parameters.
4. Other Income shall not be considered for calculation of Annual Turnover.
5. Value mentioned in technical criteria clause 2.0 is inclusive of taxes.

## **NIT Conditions**

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a **crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai**) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
5. **Being work Contract benefit to MSE/Udyam vendor is not applicable in this package**
