**Instruction for e-bidding:**

1. The bidder must have Digital Signature Certificate (Class-III).
2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

## QUALIFYING REQUIREMENT

**Name of Work: “CLEANING, SS LINING & REPAIRING OF RAW COAL BUNKER at PP2 Durgapur”.**

### **1.0 Financial Criteria:**

**1.1 Turnover:** The Average Annual Turnover of the Bidder, in the preceding 03 (Three) Financial Years, as on Date of Techno Commercial Bid opening, shall not be less than **Rs. 163.20** Lakhs (Rupees One Crore Sixty Three Lakh Twenty Thousand Only).

### **2.0 Technical Criteria:**

2.1 The Bidder must have successfully executed the works of Inspection & Rectification/ Erection of Bunkers OR Erection/ Overhauling jobs of Ducts/ Dampers/ Gates/ Air Preheater/ Boiler Pressure Parts/ ESP OR Erection of Boilers/ Mills/ Structures of minimum height 30 meters in any power plant/ process industry.

2.2 The Bidder must have executed works mentioned under 2.1 above within preceding 7 (Seven) years from the last date of techno commercial bid opening, having executed value as under –

(a) Single Work Order of value not less than Rs. **130.56** Lakhs (Including Taxes & Duties)

OR

(b) Two Work Orders of value not less than Rs. **81.60** Lakhs each (Including Taxes & Duties)

OR

(c) Three Work Orders of value not less than Rs. **65.28** Lakhs each (Including Taxes & Duties)

### **Notes:**

1. The Word “**Executed**” means that the Bidder should have achieved the progress specified in the QR para 2.2 even if total contract/ work order is not completed/ closed. The same shall be supported by documentary evidence issued by the owner/ employer such as Completion Certificate/ Joint protocol / Running / Final Bills etc.
2. For Financial selection Criteria, QR para 1.0, Bidder must submit copy of Audited Balance Sheet and Profit & Loss Account for the specified period. In case, where audited results for the Last Financial year as on the date of Techno commercial bid opening, are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from the practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year, shall be considered for evaluating the financial parameters.
3. All values as mentioned in 2.2 and 1.1 shall be inclusive of all taxes and duties.
4. Other Income shall not be considered for calculation of Annual Turnover.
5. Necessary documentary evidence in support of the above criteria of QR is to be furnished by the bidder.

## **NIT Conditions**

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a **crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai**) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
5. Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee.  
*(Subject to submission of copy of registration giving details, such as validity etc.).*
6. Note: Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
