1. The bidder must have Digital Signature Certificate (Class-III).
2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

## QUALIFYING REQUIREMENT

Name of Work: **“Construction of Retaining wall at emergency coal stockyard, RCC drain and Ramp at Track Hopper area and RCC Ramp at lagoon-1 of PP3 Ash Dyke, NSPCL-Bhilai”.**

### **1.0 Technical Requirement:**

1.1 The bidder should have executed Similar Work(s) during the preceding 7 (Seven) years reckoned as on the date of technical bid opening having,

a) Executed value not less than **Rs. 77.49 Lakhs** in a Single order.

OR

b) Executed value not less than **Rs. 48.43 Lakhs** in two orders each.

OR

c) Executed value not less than **Rs. 38.74 Lakhs** in three orders each.

### **2.0 Financial Requirement:**

2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs.96.86 Lakhs (Rupees Ninety Six Lakhs and Eighty Six Thousand Only)** during the preceding three (03) financial years as on the first schedule date of technical bid opening.

Notes:

I. The phrase "**Similar work**" means "**Civil Construction or Civil Maintenance Works consisting of reinforced cement concrete (RCC) work**".

II. The word "executed" at clause 1.1 means, bidder should have achieved the criteria specified in above QR even if the total contract is not completed/ closed. The same shall be supported by documentary evidence (copies of RA Bills, Relevant PO copy and Work completion Certificate/ RA bill/ Final Deviation Statement) issued by the Owner/ Employer.

III. Values as per Clause 1.1 and 2.1 shall be considered inclusive of taxes & duties.

IV. Other income shall not be considered for arriving at annual turnover.

V. In case where audited results for the last financial year as on the first scheduled date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from a practicing Chartered Account certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO/ Proprietor/Partners as per the format enclosed in the bidding documents stating the financial result of the company are under audit as on the date of Technical bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

## **NIT Conditions**

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a **crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai**) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
5. **The subject work being works contracts, benefits under public procurement policy for MSEs shall not be extended against this tender.**
6. Note: Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
