**Instruction for e-bidding:**

1. The bidder must have Digital Signature Certificate (Class-III).
2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.

**3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:**

- a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in forms, till 17.07.23 to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at [nbanerjee@nspcl.co.in](mailto:nbanerjee@nspcl.co.in) or [rnshukla@nspcl.co.in](mailto:rnshukla@nspcl.co.in) or [rashmikumari@nspcl.co.in](mailto:rashmikumari@nspcl.co.in).
- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidder's SRM Credentials (User ID along with initial Password) to them.
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## QUALIFYING REQUIREMENT

Name of Works: "SUPPLY, ERECTION & COMMISSIONING AND COMPREHENSIVE AMC OF CCTV SYSTEM, CPP-II (2X60 MW)"

### 1.0 FINANCIAL CRITERIA:

1.1 Turnover: The average annual turnover of the Bidder, in the preceding three financial years, as on date of Technical bid opening shall not be less than Rs. 215.10 Lakhs (Rupees Two Crore fifteen lakhs and ten thousand only).

### 2.0 TECHNICAL CRITERIA:

2.1 The bidder should be a Manufacturer of CCTV Cameras or an authorized system Integration Partner of the Manufacturer of CCTV Cameras for CCTV Surveillance system integration.

AND

2.2 The offered combination of camera types and video management software for CCTV system should have completed at least one year of satisfactory operation prior to the date of Technical Bid opening in commercial or office building or industrial set up.

AND

2.3 The Bidder should have successfully executed similar works of order values as mentioned here under within preceding 07 (Seven) years as on the date of technical bid opening with either of the following:

(a) Single Work order of value not less than Rs. 114.72 Lakhs (Including of taxes & duties).

OR

(b) Two Work Orders of value not less than Rs. 71.70 Lakhs each (Including of taxes & Duties).

OR

(C) Three Work Orders of value not less than Rs. 57.36 Lakhs each (Including of taxes & duties).

### NOTE:

1. Similar Work means, Supply, Installation and Commissioning of CCTV Camera System.
2. The Word "Executed" means that the bidder should have achieved the progress specified in the QR even if total contract/order is not completed/ closed. The same shall be supported by documentary evidence issued by the owner/ employer such as Completion Certificate/ Joint protocol /Running/Final Bills.
3. For Financial selection Criteria, QR para 1.1, Bidder must submit copy of Audited Balance Sheet and Profit & Loss Account for the applied period. In case, where audited results for the Last Financial year as on the date of technical bid opening, are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from the practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year, shall be considered for evaluating the financial parameters.
4. Other Income shall not be considered for calculation of Annual turnover.
5. Necessary documentary evidence in support of the above criteria of QR to be furnished by the bidder.

## NIT Conditions

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
5. Being work Contract benefit to MSE/Udyam vendor is not applicable in this package
