## **QUALIFYING REQUIREMENT**

1. External Painting work of Residential and non-residential buildings at NSPCL Township, Bhilai.

The Bidder who wish to participate in the bidding shall satisfactorily establish that they fulfill the following qualifying requirements:

- 1. The Average annual turnover of the bidder, in the preceding Three (3) financial years as on the date of bid opening shall not be less than Rs. 63.85 Lakhs.
- 2. The bidder should have executed either of the following completed similar works within preceding 7 (seven) years reckoned as on the date of bid opening:
  - a. Three similar completed works costing not less than the amount equal to Rs. 38.31 Lakhs each (inclusive of service tax)

OR

 Two similar completed works costing not less than the amount equal to Rs. 47.89 Lakhs each (inclusive of service tax).

OR

c. One similar completed works costing not less than the amount equal to Rs. 76.62 Lakhs (inclusive of service tax).

#### Note:-

## Similar works means:-

The completed works comprising building construction work and/ or building painting work.

**Completed means:-** The executed/ completed portion of BOQ, even if the work has not been completed in totality (subject to furnishing of documentary proof of executed value of the work).

# **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NSPCL payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.

- 5. Small-scale industries registered with NSIC shall be exempted for payment of EMD provided the certificate is related to the subject work only, and the quoted value is within the monetary limit for the said unit set by NSIC.

- 6. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
