QUALIFYING REQUIREMENT

Biennial contract for Stone Picking from running conveyors in CHP, PP-II, NSPCL-Bhilai.

- 1. The bidder should have valid independent PF code.
- 2. The bidder should have an average annual financial turnover not less than Rs. 22.77 lakhs during the last three financial years preceding Bid Opening Date.
- 3. Bidder should have experience of at least two year of stone picking from running coal conveyors work in last seven years, ending last day of the month, preceding NIT publication date.
- 4. The bidder should have experience of successfully executing similar works during the last seven years, ending last day of the month, preceding NIT publication date of following values:
 - Single contract of value not less than Rs. 36.43 lakhs.

OR

• Two contracts of value not less than Rs. 22.77 lakhs each.

OR

• Three contracts of value not less than Rs. 18.21 lakhs each.

Notes:

 Similar work means execution of picking up of stones or coal boulders or foreign materials from running coal conveyors of thermal power stations of minimum capacity 30 MW.

NIT Conditions

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NSPCL payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. Complete set of bidding documents are also available on NTPC website www.ntpctender.com prospective bidders can down load the same for submission of bids after tendering the cost of bidding documents directly on the website.
- 3. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.

Small-scale industries registered with NSIC shall be exempted for payment of EMD provided the certificate is related to the subject work only, and the quoted value is within the monetary limit for the said unit set by NSIC. (Subject to submission of copy of registration giving details, such as validity, monetary limit, etc.)
- 6. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
