QUALIFYING REQUIREMENT

Overhauling & Routine Maintenance of Milling System & Burner Block, Expansion Power Plant, NSPCL-Bhilai.

- 1. The agency should valid P.F Registration number.
- 2. The bidder should have an average annual turnover during the last **3 years ending 31** march of the previous financial Year, not less than **Rs. 33.83 lacs**.
- 3. The bidder should have executed work of Overhauling/Routine Maintenance/ Erection and commissioning of coal Mills type "XRP-803" or bigger size in 200 MW or above units for any PSU/Govt. Dept./Public Ltd during last seven years, ending last day of the month previous to the one in which bids are invited of the following value.

Single Order having a value not less than Rs. 54.128 lacs.

or

Two orders having a value not less than **Rs. 33.83 lacs** each.

or

Three Orders having a value not less than **Rs. 27.06 lacs** each.

Note:

- The agency should have executed the work (s) as mentioned at (3) above, directly under; "PSU"/joint venture of a PSU"/Govt"/Quasi Govt. Deptt."/"Owner" (ie end user).
- Bidder has to produce documentary proof for executing work as mentioned above in condition 3.
- For Values as per CI-3 shall be considered inclusive of service tax.

NIT Conditions
