QUALIFYING REQUIREMENT

Monitoring & Management of Water Quality, O&M of WCTP and other services, PP-II, NSPCL-Bhilai.

- 1. The Bidder should have executed work of
 - a) Operation of water treatment plant for DM water production capacity at least 50 m3/ hr.
 - b) Boiler water treatment (monitoring and analysis of boiler water chemistry parameters) and quality management.

for at least one year in last seven years ending last day of the month previous to the one in which bids are invited.

- 2. The Bidder should have executed operation/O&M work of DM plant or WCTP (Water Chemical Treatment Plant) during last seven years, ending last day of the month previous to the one in which bids are invited of the following value:
 - a) Single Order having a value not less than Rs.121.03 lakh.

Or

b) Two Orders having a value not less than Rs.75.64 lakh each.

Or

- c) Three Orders having a value not less than Rs. 60.51 lakh each.
- 3. The bidder should have an average annual turnover during the last 3 years, ending 31st march of the previous financial year, not less than 151.28 lakhs.

Note:

- 1. Bidder has to produce documentary proof for executing work as mentioned above in condition 1, 2 & 3.
- 2. The executed values for clause-2 above shall be considered inclusive of Service Tax.

NIT Conditions

- Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of <u>NSPCL payable at Bhilai</u>) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.

Small-scale industries registered with NSIC shall be exempted for payment of EMD provided the certificate is related to the subject work only, and the quoted value is within the monetary limit for the said unit set by NSIC. (Subject to submission of copy of registration giving details, such as validity, monetary limit, etc.)
- 6. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
