1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

4. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

2. Inspection: Pre Dispatch Inspection(PDI) shall be carried out at vendor works as per approved Drawings & QAP, AS PER ANNEXURE-"DGP-A".

5. For NSPCL Durgapur One Set of Grinding Elements consists of "1 no. of Top/Upper grinding ring + 1 no. of Bottom grinding ring (both as M4596020136), 10 no. of Grinding balls (as M4596020134) and 1 no. of filler ball (as M4596020155)".

6. Procurement of complete set of grinding elements for NSPCL Durgapur shall be done from single source on package basis. The Guarantee clause as per Annexure-"DGP-B" will not be applicable for filler ball (i.e. M4596020155).

7. Material specification for Top/Upper & Bottom Rings shall be NI HARD-IV and that of Grinding & Filler ball shall be CrNi-108(chrome nickel-108) as per Annexure-"DGP-D". However, the bidders are permitted to su pply suitable higher grade material for complying/exceeding the minimum guaranteed life without compro mising the guarantee clause.

8. The agency shall be allowed to collect the available coal analysis data and may collect samples of coal f or analysis at their end before quoting.

9. If the bidder changes the material specification as mentioned in cl.5, then bidder shall submit the detail drawings mentioning weight of each ring and ball and quality plan in line to the approved "QAP" as per Ann exure-"DGP-A" along with the offer submission.

10. Grinding Rings with Grinding Balls are as per Drawing No. A1/308/02.54.43020 C & A1/308/02.54.4302 1 B). Filler ball material specifications will be same as that of Grinding ball except differences in its OD and thickness:

Grinding Ball Size: OD 750 mm. (+5, -0) and ID 580 mm.

Grinding Ball Wall Thickness: 85-90 mm.

Grinding Ball weight, approx: 985 Kg

Filler Ball size: OD 680 mm, ID 580 mm

Material Specification and QAP for Filler ball will be same as that of grinding Ball as per the Annexure: "DG P-A".

11. Ball numbers and weight should be marked on each ball. This is mandatory & included in quality plan f or inspection.

12. Final Inspection will be done by NSPCL/NTPC Inspecting Official preferably within 7 days on intimation f or inspection by the vendor.

13. Payment Terms: 95% payment within 10 days after receipt and acceptance of the material at NSPCL Site Stores and Balance 5% payment shall be release only after successful submission /Acc eptance of PBG at NSPCL.

14. Delivery schedule: First set to be delivered within three months from the date of award. For next seve n sets, delivery schedule shall be at least one set in each month starting from the fourth month. Filler Ball may not follow the delivery schedule as mentioned.

15. Entire delivery has to be completed within 10 months from the date of award and material has to be d elivered at NSPCL Durgapur.

16. Guarantee clauses: Applicable only for Grinding Rings and Grinding Balls and shall be adhered strictly as per Annexure: "DGP-B". Filler balls shall not be considered in Guaranteed performance evaluation and r etention of PBG.

17. Actual running hours shall be logged in NSPCL Durgapur Records.

18. Additional Tender specific T&C ,Forms & format attached as "Buyer Added Bid Specific ATC"

19. Wear limit/Exhaustion limit of the elements shall be as per Annexure: "DGP-G".

20. Performance Guarantee clauses shall be as per Annexure: "DGP-E" and will be applicable on to tal PO value. The vendor has to submit a performance bank guarantee of 5% of the total PO value towards performance guarantee for a period of 24 months.
